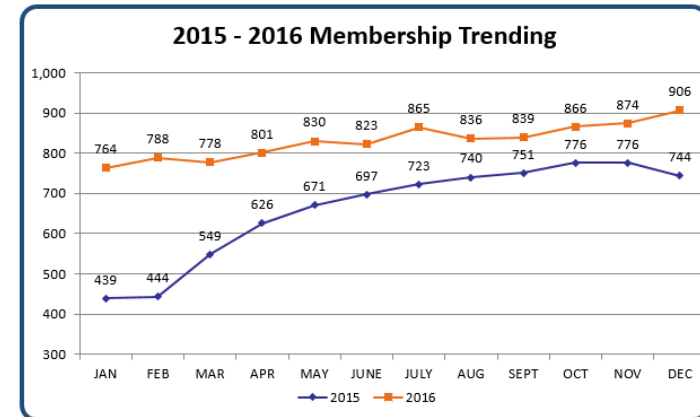

TREASURER'S REPORT 2016

- IAP2 USA ended 2016 in a positive financial condition, with end-of-year assets of \$129,149, of which \$22,654.26 remained restricted as reserve.
- Total income for 2016 was negative \$33,810 (revenues vs expenses). This is expected in a non-conference year. Top revenue generator was membership at \$77,000
- Administrative support continued to account for the majority of Affiliate expenses in 2016.
 - IAP2 USA hires four contract staff
 - Executive Manager – 50 hours/month
 - Financial Administrator – 30 hours/month
 - Membership Services – 94 hours/month
 - Training Coordinator – part-time, works on commission
